This invitation for Expression of Interest follows the General Procurement Notice for the Ministry of Finance and Planning for Financial Year 2017/2018 for this Project which appeared in the Ministry's and PPRA websites; (www.mof.go.tz & www.ppra.go.tz) respectively. Also, was advertised in the Tanzania Procurement Journal of Public Procurement Regulatory Authority.
2. The Government of Tanzania through Public Financial Management Reforms Programme has set aside funds for the operations of the Ministry of Finance and Planning during the Financial Year 2017/2018. It is intended that part of the proceeds of the fund will be used to cover eligible payment under the contract for Provision of Consultancy Services to Develop PFM Communication Strategy for the Ministry of Finance and Planning (Vote 50).
3. The Ministry of Finance and Planning now invites eligible Consulting Firms to indicate their interest in providing the required services.
4. Interested Consulting Firms must provide information indicating that they are qualified to perform the services by submitting consultant's profile, description of similar assignments, experience in similar conditions, availability of appropriate skills among staff, etc. Consultants may associate to enhance their qualifications.
5. Consulting Firms are requested to submit their consultant's profile including description of similar assignments, experience in similar conditions, availability of appropriate skills among staff, CV's for each staff as required and shown in the

Terms of Reference in one original plus Three (3) copies on or before **Tuesday,13th February, 2018 at 10:00 hours local time**. The Consultant's Profile shall be enclosed in one envelope and clearly marked "*Provision of Consultancy Services to Develop PFM Communication Strategy for the Ministry of Finance and Planning (Vote 50)*" and submitted to the following address: the Director of Procurement Management Unit, Ministry of Finance and Planning, 5th Floor, Treasury Square Building, 18 Jakaya Kikwete Road, P.O. 6. The opening of Consulting Firm Profile will take place immediately after the deadline for submission, at the Treasury Square Building, 5th Floor, Conference Room No. 5-33. Ministry of Finance and Planning, 18 Jakaya Kikwete Road, P.O. Box 2802, 40468 - Dodoma. Individual consultants are invited to attend the opening ceremony.

The Consulting Firms will be selected in accordance with the procedures set out in the Public Procurement Act No.07 of 2011 (as amended 2016) and the Public Procurement Regulations 2013 - Government Notice No. 446 of 2013 (as amended 2016 through GN; No. 333 of 2016). Selection will be conducted under Consultants Qualification selection procedures as specified in the Public Procurement Regulations.
8. Profile of all Consulting Firms will be evaluated on the basis of the criteria shown in the Instruction to Consultants Document.
